A discussion was held regarding camera helmets with Attorney DiRaddo. Mr. DiRaddo noted camera helmets are not required equipment and advised against their use.

Mr. Beavers noted a change to the OSHA regulations and questioned the impact to the District. Mr. DiRaddo stated the regulation applies to employers with six or more employees.

Chris Beach presented the board with plans of the new fire hall. The Route 5 property is estimated to be 7 1/4 acres. The purchase will require a subdivision approval from the town planning board and two surveys. Approximate cost of surveys is \$7,000 and \$9,500.

Attorney DiRaddo suggested it may be useful for the District to develop a time- table for the project. The Commissioners agreed Mr. DiRaddo has permission to write a purchase offer for the property, subject to their approval and contact Passero Associates and Peter Skivington on their behalf. Next steps include having the property appraised, building plotted on new survey and deciding how the project will be financed. Possibly a BAN or permissive referendum to move monies from the equipment reserves to the building reserves.
