Motion #107-2019

• Mr. Schroeder made a motion, seconded by Mr. Cook and all approved the purchase of ten camlocks at a cost of \$2,090, a revolution intake valve at a cost of \$1,599 and long handle cap at a cost of \$154 from MES. A 2nd quote for the purchase of the intake valve was attempted from Grayson Clark but they did not offer the size required.

Foremost. The AEDs are compatible with the ambulance and were purchased as best value for the District and community.
