- Mr. Dutton provided an update on the Building Reserve Fund. A resolution must first be passed by the Board containing specific language regarding what the fund will be used for, a 30 day notice must be published in the newspaper and a special election held. Ray Di Raddo will be consulted for proper resolution language.
- Mr. Dutton reported the antenna has been installed by the village and the county programmed it with no issues.
- Mr. Beavers noted the district may want to consider installing remote control
 overhead doors for security and energy efficiency. Mr. Dutton added he believes the
 village has a contract with Overhead Door and will contact Chris Buckley to obtain a
 quote for four doors.
- Mr. Dutton stated Churchville has provided the quote for #116 refurbishment. Two additional quotes must be obtained per the procurement policy.
