Motion #109 - 2022

Mr. Beavers made motion, seconded by Mrs. Churchill and all approved to accept the July 13 and July 28 meeting minutes with the following amendments. Mr. Beavers made a motion, seconded by Mr. Cook and all approved reinstating Carl Strange to active membership pending Caledonia Fire Department approval.

A quote from Eliza Co was obtained for \$2,579.60. Gear order includes boots and new additional thermal layer. Delivery is estimated to be six months out.

- Chief Churchill will obtain pricing on two 10 x 10 pop up tents and six chairs.
