## Motion #103-2023

 Mrs. Churchill made a motion, seconded by Mr. Cook, and all approved the Fire Report for July as presented.

## Motion #104-2023

• Mr. Beavers made a motion, seconded by Mrs. Churchill, and all approved allowing the Explorers to take the van to the FASNY Convention in Niagara Falls on September 12.

## Motion #105-2023

• Mr. Beavers made a motion, seconded by Mrs. Churchill and all approved sending #116 to the Rush parade with a qualified driver on 8/11.

### Motion #106-2023

- Mrs. Churchill made a motion, seconded by Mr. Beavers, and all approved the purchase of a black printer cartridge in the amount of \$238.89.
- The FASNY RAMS program was discussed. Deputy Chief John Kellen will obtain East Avon's RAM program for review.
- It was also noted fees charged by the Boy Scouts for the Explorer Program could be passed on to the Fire District.
- Livingston County has earmarked a trailer for Caledonia.
- Deputy Chief John Murray noted the following:
  - The drill schedule was reviewed for the months of August, September, October, November, and December.
  - PERMA update was provided.
  - The Livingston County Chief's meeting agenda items were reviewed.
  - Listing of members who are past due on their physicals was reviewed.

• Waiting on pricing for five sets of gear for 2024. Delivery is estimated for April.

### Motion #107-2023

Mrs. Churchill made a motion seconded by Mr. Cook and all approved Chief Churchill sending registered letters to members who are not current on their physical, noting their noncompliance and allowing them 30 days to contact him. If no response is received the firefighter will be moved to an inactive status.

  - Two O2 sensors need to be replaced in the Sensit meter.
  - Ballistic vests have been ordered and are expected to be delivered in 12 weeks.
  - Pump tests will be performed on #118,114 and 116.
  - Annual maintenance for trucks will begin.
  - Batteries for #116 were installed.
  - #119 body and generator check.
  - There are possibly three dry hydrants that need to be looked at for repairs.
- Deputy Chief John Kellen reported a battery-operated extrication tool has been donated to the Fire District. He will find out where it can be taken to be evaluated.

#### Motion #110-2023

  - An EMS class will be offered in September. Two people have signed up already.
  - Patient Care Reports must be completed, and he is reviewing available options for this standard form.
  - It is anticipated an initial SOG will be completed within a few days and a final draft by the September Fire District meeting.
