EMS/EMT Report:

Motion #121-2023

Mr. Beavers made a motion, seconded by Mrs. Churchill, and all approved the Standard Operating Guidelines EMS Standards as presented.

 - Patient Care Reports have been finalized at a cost of \$60 for 100 carbonless forms.
 - Will be in contact with Livingston County EMS Karen Werd to fine tune report filings.
 - Two medics are temporarily on inactive duty,
- Mr. Dutton stated EMS gear is needed. It may be possible to use outdated gear that can't be used for firefighting.
- Mike left the meeting at 7:10 pm.

Fire Hall Construction Update

- Mr. Dutton stated the final floor plans have been completed for the Fire Hall.
- Mr. Dutton requested and has received a proposal from Bernie Donegan to act the District's financial planner. Proposal was distributed to the Board.
- Mr. Dutton noted Magne Grip has confirmed the exhaust system can be moved to the new Fire Hall and will submit a plan including any system updates suggested.
- Mr. Dutton reviewed the amounts available for the Fire Hall acquisition.

Motion #122-2023

• Mr. Beach made a motion, seconded by Mrs. Churchill, and all agreed to move forward with the permissive referendum that will allow removal of existing funds from the Capital Building Reserve for Fire Hall acquisition expenses.

Fire Commissioner's Reports

• Mr. Dutton stated the FASNY RAMS program will be put on hold for now.
