- A car seat check is planned with no specific date yet. Mrs. Churchill has been certified to do the checks.
- Thirty firefighters obtained their physicals on Monday at the Fire Hall by Northern Star Medical.
- Vehicle Update
 - #114 The truck is too old for rocker arm recall to apply.
 - #114 Right dump shoot. Waiting.
 - Tahoe is at Bob Johnson's to repair A/C. Oil change also.
 - Penn Detroit will come to Fire Hall to perform chassis service and NYS inspections on fire trucks.
 - Van and #112 will be brought to Caledonia Garage for NYS inspections and any needed maintenance.

Fire Hall Construction Update

• Mr. Dutton noted the Building Committee met last night. Kevin Donaghue has been working with Passero to reduce the size of the building and will present the new estimate at the June 25th meeting. Kevin has also been in contact with Donegan to discuss bonding the project.

Fire Commissioner's Reports

• Mr. Beavers noted the Association of Fire District's will hold a "Coffee with the Commissioners" on Saturday regarding the proposed OSHA changes.

• Mr. Dutton stated VFIS (Cancer disability insurance carrier) has suggested covered firefighters review their beneficiaries and has provided a form. Sue will distribute the forms to covered firefighters.

Secretary Treasurer's Report

- Caledonia Fire Department reimbursed their portion of the insurance premium in the amount of \$7,395.33 and generator invoices from Cummins in the amount of \$2,117.56 billed to the District by mistake.
- Last month voucher #65 was payable to Boundtree (EMP) in the amount of \$279.18 but the check was mistakenly made out to Emergency Responder Products. A check was reissued to the correct vendor and a check was received from Emergency Responder Products. The voucher # is 65a on the check and abstract.
